#### **VB** Procedure

- + 2 step application: Expression of Interest and Full Application
- + Decisions on both steps are taken by SC JS only makes recommendations
- + Except for 1st call All applicants must go through both steps



## **VB** Project Idea

- + Submission online via Programme's website
- + Check against Programme objectives
- Allow for informal feedback prior to submission to formal call
- + No formal pre-assessment procedure!



## Guiding principles for all applicants

- + Cooperation
- + Innovativeness
- + Additionality
- + Integrated territorial development
- + Sustainable development
- + Equal opportunities and non-discrimination
- + Links to other policies and funds



## Golden Rules from the decision-makers

- + Easy language (answering the right questions)
- + Be very clear about the assumptions behind the project
- + Is it clear why all of the actions included are being planned?
- + Is there a clear logic for moving from one action to the next?
- + What would happen if one activity needed to be changed? Are they all necessary?
- Show the added value of each result / output for each partner and for the North Sea Region
- + Show how you will focus communication. In particular, have you selected the right target groups and appropriate channels / means for reaching them?
- + Explain the road to the application. Why has the partnership decided that this project is the solution?
- + Describe what you want to change and where (geographically)
- + What could go wrong? Show you are aware of the main risks and are managing them
- + How will you test whether the desired change has been delivered?
- + Embed your project in the context of regional strategies and other programmes
- + Be concise!



Assessment Criteria – Are linked directly to specific sections of the Full Application

**Strategic:** Project Context, Cooperation Character, Results and Outputs, Partnership Relevance

**Operational:** Management, Communication, Work Plan and Budget

**Example of what the Assessment Criteria will look like:**

#### Assessment Criteria – how?

#### **Assessment Grading:**

- + **Very strong** The application addresses all relevant aspects of the criterion convincingly and successfully. The answer provides all the information and there are no concerns or areas of weakness.
- + **Strong** The application addresses the criterion well, although some small improvements could be made. The answer gives clear information on all or nearly all areas.
- + **Sufficient** The application addresses the criterion, but there are weaknesses. There are several areas where detail is lacking or the information is unclear.
- + **Insufficient** The application fails to address the criterion adequately and/or the information provided is not in line with programme rules/regulations. The answer does not correctly address the question asked.
- + All applications must receive a minimum of 'Sufficient' in every category in the to be **considered for a recommendation of approval.**



### VB Assessment Procedure: Expression of Interest

- + Assessed using a subset of the full assessment criteria
- Grades: Very Strong, Strong, Sufficient, Insufficient Must receive minimum of Sufficient in each category
- Must receive positive decision by Steering Committee in order to move forward with Full Application (except 1st call)
- + If rejected, re-submission is possible



# 2 Stages of the Technical Assessment for Full Applications:

-Eligibility Check: Appendix (10 pages or less), Letters of Intent correctly uploaded, location of the Lead Beneficiary, all self-declarations included (if applicable for State Aid schemes), start and end date of the project etc...

All applications must first pass the Eligibility Check

-Strategic and Operational – quality assessment



# Recommendation by the Joint Secretariat

#### Other factors which are considered:

- changing policy and context,
- projects approved to date,
- available budget,
- -overlaps with other project proposals,
- shifting national and EU priorities,
- new rules and regulations
