Reporting

- + Progress Report 1 has been submitted on 15 December 2017
- + Evaluation process is almost completed. Initial responses from the Joint Secretariat are positive.
- + Rijkswaterstaat expects to be able to transfer the relevant share of grant to all the beneficiaries in mid April

Report (deadline December 15th) Full Report Cut-off point: September 15th







Preparation of Progress Report 2

Report must be submitted online through OMS.

- Progress activity report
- Finance report

Project Report 2 should be submitted on 15 June 2018 covering project period 16-9-2017 till 15-3-2018.

It is possible that the reporting deadline will be extended as a result of the intended Request for Major Change.

Preparation of Request for minor Changes

Submitting minor changes can be done during the all project period.

For example,

Changes between budget lines of the same beneficiary, without changing the total budget of the beneficiary, can be solved with a minor change.

Subjects:

+ Budget changes for HHSK, Skane and maybe others...

We are planning to submit some minor changes early April 2018.





Preparation of Request for Major Change

The lead partner will submit a Request for Major Change <u>after</u> the evaluation of Progress Report 1 has been completed.

Subjects:

- + Adding HAN University of Applied Sciences (The Netherlands) as a new partner to the project consortium as a replacement of inactivated partner Triple Bridge.
- + (Adding Esjberg Kommune (Denmark) as a new partner to the project consortium.)
- + (Budget change. Creating budget for the scientific partners to write the final report.)





Preliminary reaction of Interreg NSR

- + The project budget for the FAIR project cannot be increased. It is one of the conditions for the SC approval of the project
- + Only reallocation among the EU partners
- + Adding HAN as new partner is not a problem, since the total budget will not change
- + The additional budget for Esbjerg Kommune has to be provided through savings in budgets of the partners and to be reallocated to the new partner.
