Priority 3 – Sustainable North Sea Region

- 3.1 Demonstrate new and/or improved methods for improving the climate resilience of target sites
- Number of new and/or improved climate change adaption solutions demonstrated









Priority 3 – Sustainable North Sea Region

- 3.2 Develop new methods for the long-term sustainable management of the North Sea ecosystems
- Number of sites managed using new solutions
 supporting long-term sustainability









Full Applications approved and applying Call 1

- 3.1 3 projects approved
- 3.2 2 projects approved
 ERDF granted €13,103,049
 Call 2
- 3.1 5 project applied
- 3.2 4 projects applied *ERDF requested* €22,897,521







Expressions of Interest

Call 1

- 3.1 0 Eol approved not yet applied
- 3.2 1 Eol approved not yet applied *ERDF* €3,200,000

Call 2

- 3.1 3 Eols applied
- 3.2 6 Eols applied *ERDF requested* €16,288,376







Situation after Call 2 - Guestimate

Funding allocated to approved projects

• €24,551,809

Approved Eols which are approved as FAs in call 3

• € 8,144,188

Remaining budget for Call 4 Expressions of Interest

• € 8,580,120

The approved projects

- 3.1 BwN Demonstrating Building with Nature solutions that utilise natural processes to deliver flood protection and coastal erosion management
- 3.1 Fair Flood infrastructure Asset management and Investment in Renovation, adaptation and maintenance
- 3.1 TOPSOIL Addressing the challenges related to the top soil and groundwater in connection with climate adaptation







The approved projects

- 3.2 NorthSEE A North Sea Perspective on Shipping, Energy and Environmental aspects in Marine Spatial planning
- 3.2 WaterCoG Water Co-Governance for sustainable ecosystems by way of adopting new participatory, ecosystem service based approaches









What are we still missing?

Priority 3.1 Climate recilience - Actions not addressed:

- Adaptation of new and/or improved methods for tackling other effects of climate change
- Predict and monitor other climate change impacts – essential preventive actions







Examples of topics under 3.1 not currenly addressed in projects

- Drought
- Invasive species
- Head stress in urban areas
- New plant and animal diseases
- Other topics?













What do we have already? (1)

Priority 3.2 Sustainable management – Projects and applications are covering 3 key indents:

- Long term sustainable strategies, NS landscapes and the North Sea itself
- New methods for tackling environmental problems
- Use participatory processes







What do we have already? (2)

The North Sea itself, topics addressed:

- Long term strategies, protection and the use of maritime space
- Management and recovery of migratory fish stocks
- Pollutants (only weakly addressed)







What do we have already? (3)

Land and fresh water environment, topics addressed:

- Fresh water nutrients, eutrophication and chemical pollutants
- Ecosystems restoration, management and shared ecosystems
- Loss of biodiversity









The rejected projects

- Weak results (outputs/deliverables)
- Weak logic
- Weak transnationality
- Activities do not match objectives
- Weak added value
- Lack focus
- Insufficient benefit outside the partnership
- Insufficient understanding of state aid and other financial issues
